The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL & STAFF SERVICES **2,950**
 Our fee includes 24 hour licensed staff on call, but is not limited to, response to the initial request for service; arrangement conference w/ family and/or responsible party, preparation and filing of required certificates and permits, drafting and placement of obituaries and death notices, planning of funeral arrangements; coordination with cemetery, crematory, vault companies, reception hall, caterers, and others as required. Also included in this charge are the following overhead expenses relative to our facility; insurance, maintenance, utilities, administrative, equipment and inventory.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING **585**
Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, that does not require you pay for it, such as a direct cremation or immediate burial.

If embalming is declined, the Wisconsin State Board of Health (State Statute HSS 136.04) requires a licensed embalmer to perform alternative sanitary care of the deceased. This also includes sheltering of deceased, chemicals and materials required for washing and disinfection, use of preparation room and special professional equipment, OSHA required bio-hazardous safety equipment, protective garments, and infectious waste disposal (the above charge relates to any or all of the above services).

 Cash advances are non funeral home expenses from a 3rd party, paid for on your behalf by Uecker-Witt. In addition to your selection of services and merchandise, cash advancements are itemized for the family on the final invoice. At the discretion of the director, a down payment for the cash advances may be required depending on the timeline involved.
